(\*) The posts are being re-advertised. Therefore, the candidates who have applied earlier in response to our Notice No. E-33/277 dated 7.11.2008 need not apply again. However, their candidature will be considered subject to eligibility.

(\*\*) For locomotor disability or cerebral palsy. This reservation includes earlier Notices of vacant posts issued since 2006.

These posts carry allowances, medical, LTC benefits etc. as are applicable to the employees of LNUPE, Gwalior. The posts are non-Government under LNUPE, Gwalior and will be governed by the New Pension Scheme introduced by the Government of India w.e.f.1.1.2004.

The prescribed application form along with minimum essential/desirable qualifications, experience upper age-limit etc. may be accessed/downloaded from Institute's website [lnupe.gov.in](http://lnupe.gov.in), which also forms part of this Notice and may be used to apply for any of the posts.

The upper age is relaxable in accordance with the provisions of LNIPE SBCSR, 2006 and LNIPE Service (Recruitment) Rules, 2006, which are available on the Institute's web-site [www.lnupe.gov.in](http://www.lnupe.gov.in). under "Right to Information Act, 2005" in Quick Links at home page. It may be noted that SC/ST/OBC/PH applying for un-reserved posts are not entitled to any relaxation in age limit. However, it may also be noted that the upper age-limit may be relaxed at the discretion of the Competent Authority in the event of candidates being otherwise eligible in terms of qualifications and experience.

The cut off date for determination of eligibility including age will be the last date for submission of application form. The last date of receiving applications in the office of Registrar, LNUPE, Mela Road, Gwalior – 474 002 (M.P.) by hand/registered post/speed post is **28.2.2010**,

along with fees of Rs. 200/- (NIL for SC, ST and PH) in the form of Demand Draft/Bankers Cheque in favour of Registrar, LNIPE payable on Gwalior or paid in cash in Institute's Accounts Section and receipt in original be enclosed with the application form. Incomplete applications and those received after the closing date shall be rejected without making any reference to the candidates.

The prescribed application form may also be obtained from the office of Registrar, LNUPE, Mela Road, Gwalior - 474 002 by submitting an application on plain paper along with a self-addressed (without stamps) envelope of 30 cm x 12 cm size and a Demand Draft/Bakers Cheque for Rs. 100/- in favour of Registrar, LNIPE, payable on Gwalior or cash deposit in the Institute's Accounts Section. The forms will be sold till the last date of submission of applications.

Before filling the form, the candidates must carefully go through the "General Instructions" provided along with application form, which also forms part of this Notice/advertisement.

Candidates serving in Central Government/State Government/Autonomous Bodies should submit the applications ONLY through proper channel, failing which their candidature will not be considered.

The mere fact that a candidate has submitted application against this Notice and apparently fulfilling the criteria as prescribed for the purpose, would not bestow on him the right to be called for written test and/or interview.
